

## 2025-2026 Special Circumstances Request Consideration Form

Financial aid eligibility for the 2025-2026 academic year is calculated based on the information you provided on the Free Application for Federal Student Aid (FAFSA) using your 2023 tax return information.

The Department of Education and the Office of Financial Aid at the University of Valley Forge recognize that many families have changes in income or family situations that cannot be reflected in the 2023 tax return data. For this reason, it is possible for students to appeal their financial aid eligibility if they have unique financial circumstances.

A Special Circumstance Appeal may be filed if you have extenuating circumstances, which you believe warrant a reevaluation of your financial aid. Circumstances may include, but are not limited to:

- Loss or change of employment, including a separation from the military or retirement
- Loss or change in amount of child support, Social Security, or other benefits
- Divorce or separation of parents or spouse that occurs after the date the FAFSA was filed
- Death of parent(s) or spouse that occurs after the date the FAFSA was filed
- Unusual medical expenses (not covered by insurance) that make up more than 11 percent of your annual income
- One-time taxable income used for life changing events (e.g. IRA, pension distribution, back-year Social Security payments)

Circumstances that are **NOT** considered extenuating include (but are not limited to) standard living expenses such as utilities and mortgage expenses, car payments, credit card, other personal debt, and all other discretionary expenses.

Please allow up to 2 weeks processing time from the time all documentation has been submitted. Submitted documentation will not be returned. Please do not submit originals. Notification of the decision by the Office of Financial Aid will be sent via email. All decisions made by the Office of Financial Aid concerning special circumstances are final.
